Rules and Regulations for Ph.D. Programme (2025-26)

This Rules & Regulations regarding Ph.D. Programme are framed in accordance with University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. degree) Regulations, 2022 published in Gazette of India on 07th November 2022.

1. ELIGIBILITY

The applicant shall have to fulfill one of the following conditions for admission to the Ph. D. programme.

- 1.1. Candidate seeking admission to the Ph.D. programme shall have a Two Years Master's degree programme (in same or allied discipline) after three/four years bachelors degree programme or equivalent qualifications declared by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST and differently abled candidates.
OR
equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized, or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.
- 1.2. Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST and differently abled candidates.
- 1.3. The candidates, who have valid score for UGC-NET (including JRF)/UGC CSIR NET (including JRF/ SLET / GATE /GPAT/CEED) or DST inspire fellowship, DBT fellowship, or Quality Improvement Programme (QIP)/ National Doctoral Fellowship scheme (NDF) of AICTE or have passed M.Phil. will be exempted from appearing at the All-India Entrance Test for Ph.D. programme. However, these candidates will have to appear for interview before committee appointed by the University. These candidates should fill the form available online. The candidates who have been declared eligible by UGC for Ph.D. admission based on their NET score, subject to validity, must appear for interview for 30% weightage. The NET score will be considered for 70% weightage and interview score for 30% weightage.
- 1.4. The candidates appearing for the final year of the post-graduate examination can also apply for the Entrance Test. However, he/she will have to submit the result of qualifying examination at the time of interview, failing to which his/her claim for admission, will get automatically cancelled.
- 1.5. A candidate from any allied discipline may apply for Ph.D. in inter-disciplinary studies where research supervisor from primary discipline and co-supervisor from the allied discipline will supervise the research work. The admission to interdisciplinary studies will be decided by the University depending on its feasibility. In addition to the above, rules and regulations for Ph.D. admissions mentioned by the respective council will be applicable. For guidelines visit the following websites:

2. PROCEDURE FOR ADMISSION

- 2.1. The admission to Ph.D. programme will be based on the merit obtained by the candidate in the 'Written Entrance Test' (70% weightage) and interview (30% weightage) conducted by the University, and fulfillment of the eligibility conditions.
- 2.2. The 'Written Entrance Test' will have 50% weightage for Research Methodology and 50% weightage for specific subject. The written entrance test will be in English language only.
- 2.3. The written entrance test will be of 70 marks for duration of three hours. It consists of two sections: Section – I will be on Research Methodology and will carry 35 marks. Section – II will be on the respective discipline specific subject and will also carry 35 marks. The syllabus and exam pattern are available on the university website. (www.bvuniversity.edu.in)
- 2.4. The successful candidates will have to appear for interview before a duly constituted research committee. The candidate is expected to present his/her research area of interest through presentation. The University will call the number of eligible students for the interview based on the number of Ph.D. seats available.
- 2.5. A candidate must score minimum 50% of marks in the written entrance test (relaxation of 5% for candidates belonging to SC/ST/differently abled category). The candidates who are exempted from appearing at the All-India Entrance test for admission to PhD programme must appear for the interview.
- 2.6. The subject-wise final result of successful candidates will be notified on the university website. The candidates will be given admission to the Ph.D. degree programme according to rank and the availability of seats in the subject concerned. The rank of the candidates scoring equal marks will be decided on the basis of marks obtained by them at P.G. degree examination.
- 2.7. The candidate must note that, mere registration on the website or appearance at the entrance test and inclusion of name in the merit list does not necessarily mean that he/she will get admission to the Ph.D. degree programme.
- 2.8. The merit list of selected candidates and the waiting list (for vacant seats, if any) in order of merit shall be prepared by the concerned committee. It will be valid for that academic year only.

3. INTERNATIONAL STUDENTS

The International students who satisfy the eligibility criteria should appear for an interview before the committee constituted by the university, and based on the recommendation of the committee, will be given admission to the Ph. D. Programme.

4. PH. D. THROUGH PART-TIME MODE-

Part-time Ph.D. will be permitted, provided all the conditions stipulated in the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degrees) Regulations, 2022 are fulfilled. Ph. D. Programme through part time mode will be permitted, provided that the candidate for a part time Ph. D. programme shall submit a “No Objection Certificate” from the appropriate authority of the organization where the candidate is employed, clearly stating that:

- 1) The candidate is permitted to pursue the Ph.D. programme on a part-time basis.
- 2) His/Her official duties permit him/her to devote sufficient time for research.
- 3) If required, he/she will be relieved from the duties to complete the course work.
