- 6. Completion of Face Registration Activity at <u>ICAI Digital Learning Hub by</u> 1:30 PM of 2 Days before date of Exam
- 7. Also ensure that your **recent photo is uploaded** on your **SSP dashboard**.

8. Launch of the Assessment enables Face Authentication to confirm liveliness (Blink of eyes)
