Note: *The number of vacancies mentioned above might change depending on the ratification of the Departmental Research committees (DRC's) of respective departments.*

A) Eligibility criteria for admission to Ph. D Programme

Candidates satisfying the following two clauses shall be eligible for admission to Ph.D. programme:

- (i) Candidates who have secured **55% marks in aggregate**, or its equivalent grade "B" in the UGC 7-point scale or an equivalent grade in a point scale where ever grading system is followed, excluding grace/statutory marks, if any, **in Master's Degree** in the concerned subject/allied subject from a recognized University or in any recognized Professional Degree declared equivalent **to the Master's Degree** by the Equivalence Committee of the University or an equivalent Degree from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognised or authorised by an authority having this mandate or by an Equivalence Committee of the University. However, a relaxation of 5% of marks from 55% to 50% or its equivalent grade shall be allowed for the candidates **belonging to SC/ST/OBC (non-creamy layer)/differently-abled, Economically Weaker Sections (EWS) and other categories of candidates** as per the decision of the University Grants Commission from time to time.

Explanation:

The Departmental Research Committee (DRC) shall decide which of the subject/s is/are allied to the subject concerned in accordance with the university council resolution adopted on 24.10.2017 notified vide circular No. F (Modi-Circular-Recg/Eqv/Acad/KU/18), dated Feb.07, 2018 and shall also decide whether the degree shall be given to the candidate in the subject/discipline in which he/she has qualified his/her Master's degree or in the allied subject/discipline in which the candidate is seeking admission. The decision of the DRC shall, however, be subject to the approval of the BORS at the time of registration.

- (ii) Candidates who have qualified **UGC-NET/JRF or CSIR-UGC-NET/JRF or ICAR-NET or SET/GATE/CEED/GPAT (Graduate Pharmacy Aptitude Test) or any other equivalent test declared so by the UGC.**

Further candidates with, **M.Phil/WOS-A/INSPIRE Level-1 fellowship** and other equivalent fellowships will be eligible for admission under category-4.

B) Procedure for admission

The DRC shall fill up the available vacancies priority wise as per the following levels. The presence of DRC Observer shall be mandatory while provisionally selecting candidates for Ph.D. programme; however, marks for the interaction shall be awarded by the DRC members only. The priority to fill up the available vacancies shall be as under:

Category-1: Qualified National Eligibility Test (NET) for award of JRF/GPAT and eligible for appointment as Assistant Professor: These candidates shall be selected at the first instance against available vacancies. However, where the number of vacancies are less than the number of JRF/GPAT candidates, the selection shall be made through an interaction with the DRC. The DRC shall assess the candidates and prepare a selection list based on the following criteria:

Category-2(A): Qualified National Eligibility Test (NET) and eligible for appointment as Assistant Professor and admission to Ph.D.: The next priority shall be given to this category and the admission shall be based on the following criteria.

*The marks obtained in the NET by a candidate will be valid for a period of one year for admission to Ph.D. (**Note:** One year will be from the date of issuance of NET Certificate from the concerned agency).

Category-2(B): SET/SLET/Previously qualified NET candidates eligible for appointment as Assistant Professor and admission to Ph.D.: For left over seats, the candidates with SET/SLET/ Previously qualified NET candidates may be considered for selection. In this case the assessment shall be made as per the criteria laid down in category-1.

Category-3: Qualified National Eligibility Test (NET) for admission to Ph.D. : The next priority shall be given to the candidates who have qualified NET/GATE for admission to Ph.D. only as per criteria laid down in category 2 (A):

*The marks obtained in the NET by a candidate will be valid for a period of one year for admission to Ph.D. (**Note:** One year will be from the date of issuance of NET Certificate from the concerned agency).

Category-4: Other candidates not covered under above three categories: If seats remain available after having exhausted vacancies through categories (1, 2A, 2B & 3), the seats shall be offered to the candidates who have NET appeared score, M.Phil., WOS-A or Inspire Level-1 fellowship as per the following criteria:

Note: The NET appeared score of the year (2024) shall be considered towards assessment for the selection.

Notes:

1. The tie in the marks secured by the candidates in the merit list and interaction shall be resolved on the basis of the percentage of marks secured by them in their Master's or Equivalent Degree.
2. The list of the qualified candidates along with the waiting list will be prepared by the DRC with the main list to be signed by the DRC members including DRC observer and will be then forwarded by its Chairperson to the Dean of the School who after satisfying

himself/herself about the fairness of the selection will recommend it for approval of Vice-Chancellor through Dean Research.

3. The list of qualified candidates/waiting list will be notified by the Dean of the School concerned and will be made available on the website of the University as well as departmental website.
4. The provisionally selected candidates shall be required to get all their credentials verified in the concerned department/centre to join the Department/Centre within stipulated time.
5. Mere appearance in the list of provisionally selected candidates/waiting list shall not entitle a candidate to the final selection, if he/she is either found otherwise in-eligible or there is no vacancy available in the Department/Centre/Institute or Supervisor is not available to guide a candidate.

C) Eligibility for admission to part-time Ph.D. programme:

The basic eligibility and admission procedure for in-service candidates joining as part-time Ph. D student remains same as to the candidates for whole-time basis. The in-service candidates joining as part-time Ph. D student shall be open to only:

- i. University teachers **with at least two years of substantive service;**
- ii. Permanent scientists (Scientist A/B/C/D) from nationally recognized institutions with atleast **four years of substantive service;**
- iii. Govt. College teachers with at least four years of substantive service;
- iv. Non-teaching employees of the universities/nationally recognized educational and research institutions with at least four years of substantive service and seven years of substantive service for State/Central Govt. employees;

Applicants shall visit University website (www.kashmiruniversity.ac.in) and submit online applications by clicking Application Form for research programmes-2024 (Cycle II, November-2024) under Admission Tab of the website from 01-11-2024 to 20-11-2024. Applicants are required to deposit non-refundable application fee of Rs.100/- through online mode. In-service candidates are required to mention in the form the date of appointment/Department and Length of Service supported by documentary proof to be uploaded alongwith qualification certificates.
