Candidates are informed to visit this website before they go for Registration and Web options. Candidates are informed to upload their certificates at **<https://cets.apsche.ap.gov.in>** for verification.

*Candidates are informed that they should satisfy the eligibility criteria for admission under BCI Rules, related State G.Os and should be prepared to pay the tuition fee and other fee as applicable.

*This Notification itself is a call for counselling. No separate call letters will be sent to the individual candidates.

1. APLAWCET/APPGLCET-2024 Rank Card & Hall Ticket
2. Degree / Intermediate or its equivalent pass certificate, Consolidated Marks Memo and Provisional Certificate (PC) / Original Degree (OD).
3. Transfer Certificate.
4. S.S.C or its equivalent Marks Memo,
5. Study Certificate giving the details of past seven years of study from 1st appearance of qualifying exam.
6. Residence Certificate for preceding seven (7) years of the qualifying examination.
7. Latest Income Certificate / White Ration card, issued by the competent authority (MRO / Tahsildar) containing the name of the candidate
8. Aadhar Card or any Govt. ID (PAN / DRIVING LICENCE)
9. Caste Certificate, etc., issued by competent authority (MRO / Tahsildar) containing the name of the candidate.
10. PH/Sports/CAP/NCC / Scouts & Guides.
11. Minority Certificate (SSC TC containing Minority Status or Certificate from the Head Master).
12. EWS Certificate valid for the year 2024-25 from Mee Seva/ **Gram Sachivalayam** for OC candidates who want to claim reservation under EWS category, if applicable.

Note: The candidates who are admitted under self-support category are not eligible for Government scholarships.

Fee to be paid: (At the Time of Registration):

- 1) Non-refundable Processing **Fee Rs.500/- (SC/ST/PH) and others Rs.1000/-**. Through payment gateway (Bill desk) provided in the website **<https://cets.apsche.ap.gov.in>** by entering hall ticket number and rank/Date of Birth from **16-10-2024 to 23-10-2024** using credit/debit card/net banking/other channels.
- 2) Tuition Fee particulars and seats available under Convener Quota College wise will be made available on the website **<https://cets.apsche.ap.gov.in>**. before the commencement of Option Entry.

However, Candidates claiming **CAP/NCC/PH/SPORTS** have to attend physically for verification of certificates at Directorate of Admissions, Acharya Nagarjuna University, Nagarjuna Nagar, Guntur only on **19-10-2024**. Candidates shall upload all relevant certificates including CAP/NCC/PH/SPORTS Certificates as per time line. Original certificates will be verified on **19-10-2024**, and candidates shall produce Xerox copies of the Certificates.

Certificates to be produced by CAP/NCC/PH/SPORTS/Scouts & Guides Candidates:

1. **CAP**-Original Certificate issued by Zilla Sainik Welfare Officer (in case of Ex-Service person) Identity card and Discharge book for verification. **Candidates whose parents are domiciled in Andhra Pradesh are only eligible to be considered under "CAP" Category.**
2. **NCC**- Original Certificate issued by competent authorities.
3. **PH / SPORTS** - Original Certificate issued by the Competent authorities.

- 4. Scouts & Guides** - All the above requires to pursue certification courses, active participation and commitment to the Bharat Scouts & Guides training programme and philosophy for over 13 years, i.e., almost throughout the school and Intermediate stage of education.

A Candidate between age group of 15-18 years after completion of all above courses can only enter into Rashtrapathi Award Certificate programme.

(The decision of the verifying authority is final in respect of above special reservation categories with regards to priorities fixed).

Note:

1. (a) Eligibility for Admission into 3 year LLB course: 10+2+3 (Regular / Distance Method from any recognized university of India or outside or equivalent.
(b) Eligibility for Admission into 5 year LLB course: 10+2 (such as 11+1), 'A' level in Senior School Leaving certificate course from a recognized university of India or Outside or equivalent.

The applicants who have obtained 10+2 or graduation /post-graduation through Open Universities system directly without having any basic qualification for prosecuting such studies are not eligible for admission into law courses.

2. Mere allotment of a seat through the admission counselling will not guarantee the admission to the candidate unless he /she satisfies the eligibility criteria for admission as per the Bar Council of India Rules notified time to time.
3. Candidates who are allotted seats in a particular college shall submit original certificates in the college for physical verification. Principal of the college shall also be responsible for verification of the eligibility of the candidate for admission.
4. Tuition fee, if payable shall be paid by the candidate at the college.
