- 5) **It is to notify that as per the Judgment dated 04-11-2022 in Civil Appeal No 8037/2022 with Civil Appeal No. 8038/2022 of Hon'ble Supreme Court of India, there is no provision for revaluation of answer scripts as the procedure adopted by the University in digital evaluation of answer scripts is upheld by the Apex Court.**
