PG Registration (AY 2024-2025)

In furtherance to **PG Registration (AY 2024-2025)** notification issued vide Memo No.: **No.: RC/Regn. & Mign/Cir/2024-2025/154 dt. 21.01.2025**, it is to inform that last date for registration is hereby extended to **13.02.2025**. All concerned are requested to complete their 'Registration' against admission to PG courses (AY 2024-2025) by hardcopy submission of filled in Registration and Inward Migration Form, original Migration Certificate (if applicable), fee payment receipt / challan, copy of last appeared examination etc. at the Registration & Migration Section, Golden Jubilee Building, The University of Burdwan by **13.02.2025**.

Students taking admission for AY 2024-2025 at PG level are requested to complete their Registration at the earliest and not keep them pending, as incomplete / pending registration may lead to difficulty in receiving Admit Cards and appearance for Semester examinations.

PG Department(s) / College Authorities may collectively submit duly forwarded registration applications (along with Inward Migration Form, fee payment receipt / challan, original Migration Certificate, copy of last appeared examination etc.) at the Registration & Migration Section, Golden Jubilee Building within the given timeframe (Department/College wise). Candidates migrating to the University of Burdwan from other Universities shall be required to apply for Registration under the University of Burdwan. Candidates having previous registration under the University of Burdwan need not obtain fresh registration but may be required to apply for **Restoration**, if applicable, as the case may be.
