Application fees of **Rs. 100/-** have to be paid through SBI COLLECT.

The filled-up forms along with all testimonials photocopy are to be submitted between 12.30 to 4.00 p.m. on all working days at the office of the Department of Law (1st floor) Hazra Campus, C.U. The candidates will have to appear in a written examination of 2(two) hours duration on **24/11/2024** and Viva-Voce in due course. Those candidates who have already passed JRF / NET / SET are exempted from the written examination. Qualifying marks for the Entrance Test is 50%.

The Entrance Test will comprise B. A. LL. B. and LL.M. syllabus of the University of Calcutta. Written Test full marks 100 and Viva-voce full marks 50.
