 7. Certificate/affidavit of gap year, if any.
 8. **For supernumerary seat: Proof(s) as per clause 6.8 sub-clause 3 of Ph.D. ordinance 2024-25 and UGC NET certificate is required to be submitted before the interview.**
 9. The counseling for the admission will also be held on the same day and the candidate needs to take admission, if offered, on the same day i.e. 17.03.2025 by paying the requisite admission fee.
