## NOTIFICATION

The award of Scholarship known as "**Kurukshetra University Golden Jubilee Post Graduate Scholarships**" to be awarded to meritorious needy & deserving students of University Teaching Departments/Institutes at the campus having at least 70% marks or 7.0 CGPA/SGPA in previous examinations (combined result of 1<sup>st</sup> and 2<sup>nd</sup> Sem. exams in first attempt) out of the interest accruing from the Golden Jubilee Scholarship Corpus Fund. The guidelines for award of "**Kurukshetra University Golden Jubilee Post Graduate Scholarships**" are as under:

1. The value of each scholarship shall be Rs.10000/- p.a. and the scholarships will be awarded to 50 students of Post Graduate Courses (**except Self-Financing schemes**) of University Teaching Departments/Institute at the campus.
2. The students availing any other scholarship/stipend/financial aid/Tuition Fee Concession etc. from any other source will not be entitled for this scholarship.
3. In case, any awardee of this scholarship subsequently gets any other scholarship/stipend/financial aid/Tuition Fee Concession etc. from any other source, he/she will surrender this scholarship and refund the entire amount of the scholarship received by him/her, if any.
4. The scholarships will be awarded in the 2<sup>nd</sup> year subject to the conditions of passing with 70% marks or 7.0 CGPA/SGPA in both semesters of 1<sup>st</sup> Year (1<sup>st</sup> and 2<sup>nd</sup> Sem.) examination **without re-appear**.
5. Preference will be given to the Fatherless/Motherless students.
6. The Vice-Chancellor will have the right to increase/decrease the value and number of the Scholarship according to the interest amount available.
7. The Chairperson/Director of the concerned Department/Institute at the campus along with one Senior Most Teacher will recommend the name of **three meritorious needy & deserving students on I.U.M.S. Portal** so that the Committee may recommend the names by Interview for award of this Scholarship every year.
8. The Scholarship shall be awarded each year to the regular students of UTD/ Institute (**except Self-Finance Schemes**) on the basis of the recommendations of the Committee consisting of the following members:
  - i. Dean, Students' Welfare
  - ii. Coordinator, R.K.F.F
  - iii. Financial Advisor
