## Overview

The PGP-FABM (Post-Graduate Programme in Food & Agribusiness Management) summer placement process for the batch of 2024-26 was completed successfully on 15th November 2024. The process was carried out in a hybrid mode. 47 students of FABM Class of 2024-26 will do their summer internship in the months of April-June 2025. The successful completion of the placement process within a day is a testament to the institute's high-quality learning experience and the robust placement process that provides adequate flexibility to both recruiters and students.

The FABM students looking for summer placements were well-received by the industry and 39 companies participated in the placement process. The placements witnessed a balance of roles from all the sectors like Agri input, BFSI, Consulting, ESG Consulting, Commodity Trading, Consumer goods (FMCG), Food Processing, and other sectors.

The placement process witnessed regular recruiters who reaffirmed their confidence in the program such as Accenture, Ernst & Young (EY), Godrej Agrovet, Bayer India, United Breweries, Amul, Nestle, DeHaat, International Flavors & Fragrances (IFF), PI Industries. Many new recruiters also showed a keen interest in the batch, which is visible by the participation of industry giants like Louis Dreyfus Company (LDC), Mapro, Husk Power Systems, PCI India, Srinivasa Farms, Sahyadri Farms among others.
