- (i) **Qualifying Degree:** The requirement of the qualifying degree for admission into Ph. D. program under various Schools / Department is as follows.

 - The qualifying degree for admission into Ph. D. program under Computer Science and Applications is MCA / M. Sc. (Computer Science) / Masters' degree in Computer Science Engineering / Information Technology.
 - The qualifying degree for admission into Ph. D. program under School of Basic Sciences and Humanities is Master's degree in Physics / Chemistry / Mathematics / English.
- (ii) Candidates belonging to SC / ST / Differently-Abled category as notified by Government of Odisha from time to time shall possess a qualifying degree from an Institute / University recognized by UGC / AICTE / Central Government, with a minimum CGPA of 6.0 out of 10 or 55% of aggregate marks in respective discipline, for admission into Ph. D. program.

 - (f) SC / ST Caste Certificate, if applicable.
 - (g) Differently able Certificate, if applicable.
- (ii) Prior to the submission of the e-form (<https://tinyurl.com/OUTRPhDApplication2025>), the candidates applying for Ph. D. have to deposit a non-refundable Application Fee in online mode by scanning the QR Code provided in the e-form **through any UPI / BHIM App**, without which their application will not be submitted online and shall not be considered for scrutiny and admission into Ph. D. program 2025-26. The Application Fee to be deposited by candidates of various categories is as indicated below.
- (a) Candidates belonging to SC / ST / Differently-abled category: **Rs.200/-** (Rupees Two Hundred only).
 - (b) Candidates belonging to all other categories: **Rs.500/-** (Rupees Five Hundred only).
 - (c) **The candidates must enter the UTR Number, Date of Transaction, Name of the Bank from which the transaction is made and upload the Transaction slip, required for submitting the form.**
- (B) The applications received from the candidates shall be processed by the Ph. D. Cell, OUTR, and the list shall be notified in the website (www.outr.ac.in), latest by **26.06.2025**, indicating the candidates found suitable for online payment of Application Fee.

- (ii) The following category of candidates are exempted from appearing the OUTR-PET.
- Candidates having qualified in the UGC-NET (including JRF) / UGC-CSIR NET (including JRF / Inspire Fellow (Department of Science and Technology, GoI) / SLET / GPAT / GATE / CAT / NDF tests, and having qualifying percentile scores in their respective validity periods.
 - Regular employees of OUTR.
- (iii) The candidates of List-1, are required to appear in the OUTR-PET, which will be conducted at OUTR Campus, in physical mode, on a computerized based system. The duration of OUTR-PET shall be of 90 minutes, consisting of 70 numbers of subject specific multiple-choice questions, each carrying 01 (one) mark. The correct answer will fetch 01 (one) mark and incorrect / unanswered question will fetch 0 (zero) mark. The schedule, venue, and the result sheet (List-3) of OUTR-PET shall be published in the website (www.outr.ac.in). The eligibility criteria, academic qualifications, selection criteria etc. will be governed as per the Ph. D. Regulations of OUTR.
- (iv) The candidates of List-2 and List-3, shall be called for appearing the Pre-Ph. D. admission interview, to be conducted in respective Schools / Departments of OUTR, in physical mode, for consideration of admission into the Ph. D. program, subject to fulfilment of other norms. These candidates are required to submit a set of self-attested certificates in the respective School / Department, during the Pre-Ph. D. admission interview, and details of admission process will be notified in the website (www.outr.ac.in).

- a) **Pre-Registration Residence Period:** A candidate under Part Time / Executive Ph. D. shall put in a minimum thirty days of residence in one or more visits to the School / Department in every semester during the coursework period, until he / she gets registered for the Ph. D. program. This residence requirement shall be utilized by the candidate for the purpose of coursework preparation and appearing the semester examinations, comprehensive examination, registration seminar etc.
