

## Provisional Result of Ph.D. Research Entrance Test (RET) - 2024-25 conducted on March 5, 2025

- 1. The interview of the qualified candidates for Ph.D. admission will be conducted in the concerned departments during March 17-26, 2025. The concerned departments will directly communicate with the qualified candidates.
- 2. As per UGC Ph.D. regulations 2022, the candidates who have secured 50% marks in the Ph.D. entrance test are qualified for the interview under unreserved category, whereas a relaxation of 5.0% marks will be given to the candidates belonging to the EWS/OBC/SC/ST/PwD categories.
